## **FEES - CANVASSING APPLICATIONS**

### **Initial Morris Township Permit Application:**

Each applicant will pay a fee of \$25.00 for an annual permit, this may be paid in cash or personal check made payable to "Township of Morris".

All initial applicants will require fingerprinting and will be directed to Morpho Trak for digital fingerprinting and this fee of \$41.00 will be paid directly to Morpho Trak. This may be paid on-line during the appointment process by debit / credit card. Once the initial application is submitted the Detective Bureau will provide you with an applicant number and directions for Morpho Trak.

### **Renewal Morris Township Permit Application:**

Each applicant will pay a fee of \$25.00 for annual permit, this may be paid in cash or personal check made payable to "Township of Morris"

Renewal applicants will require the submission of a S.B.I. #212B (blue) form for each and every application and the accompanying certified check or money order in the amount of \$18.00 payable to "Division of State Police, S.B.I."

- Permit holders shall be allowed to solicit only Monday through Saturday between the hours of 9AM and 9PM.

All permits expire at the end of the calendar year on December 31<sup>st</sup>.

Any failure to prominently display the canvass permit while engaged in soliciting will result in the revocation of the canvassing permit.

Upon approval of the application, each holder of a permit to canvass will be provided a copy of the most current "Do Not Solicit" listing.
