RESOLUTION 67-26

RESOLUTION APPOINTING A SUCCESSOR TO THE COMMITTEE SEAT VACATED BY MARK GYORFY UNTIL THE VACANCY IS FILLED BY ELECTION AND QUALIFICATION OF A SUCCESSOR

WHEREAS, the Township received on February 6, 2026 the resignation of Committeeperson Mark Gyorfy ("Gyorfy") from his position as a duly elected member of the Township Committee of the Township of Morris (the "Committee"); and

WHEREAS, the Committee seat became fully vacant on February 7, 2026; and

WHEREAS, Gyorfy was elected to the Committee in November 2024 for a three (3) year term; and

WHEREAS, because Gyorfy was elected to office as the nominee of the Democratic Party, the Township of Morris Democratic Municipal Committee (the "Municipal Committee") pursuant to N.J.S.A. 40A:16-1, et seq. (the "Vacancy Law") was required to present to the governing body, no later than 15 days after the occurrence of the vacancy, the names of three (3) nominees for the selection of a successor to fill the vacancy; and

WHEREAS, in accordance with N.J.S.A. 40A:16-11, on February 20, 2026 the Township of Morris Democratic Committee submitted the names of the three nominees for the selection of a successor to fill the vacancy by appointment until the next general election; and

WHEREAS, the Vacancy Law requires that the Committee within thirty (30) day of the occurrence of the vacancy, appoint one of the three (3) nominees as successor to fill the vacancy; and


WHEREAS, the Committee has had an opportunity to review such nomination and wishes to appoint one of the nominees as the successor to fill the vacancy; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Morris in the County of Morris and State of New Jersey, as follows:

1. In accordance with N.J.S.A. 40A:16-11, Samantha G. Rothman be and is hereby appointed to the vacant Township Committee seat until the vacancy is filled by the election and qualification of a successor.
2. This Resolution shall take effect immediately.
