AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID NO. OTE 2014-4 TO EAGLE EQUIPMENT INC., D/B/A PEIRCE EQUIPMENT CO., 3388 ROUTE 22 WEST, BRANCBURG, NJ 07512, NJ 08876 FOR THE PROCUREMENT OF ONE (1) FREIGHTLINER CA/CHASSIS WITH VAC-CON COMBINATION SEWER CLEANER OR APPROVED EQUAL, IN AN AMOUNT NOT TO EXCEED \$295,203.00
