AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID OTE: 2015-1 FAIRCHILD AVENUE ROAD IMPROVEMENTS PROJECT – IN AN AMOUNT NOT TO EXCEED \$605,358.95
