## RESOLUTION NO. 99-15

AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID NO. QPA-3-2015 TO DELUXE INTERNATIONAL TRUCKS, INC., 600 SOUTH RIVER STREET, HACKENSACK, NJ 07601 – IN AN MOUNT NOT TO EXCEED \$184,668

WHEREAS, the Township of Morris has, in accordance with the Local Public Contracts Law of the State of New Jersey, received bids for the following:

PROCUREMENT OF ONE (1) 2015 INTERNATIONAL MODEL 7400 4X4 FOUR WHEEL DRIVE OR EQUIVALENT CAB AND CHASSIS, SNOWPLOW, CENTRAL HYDRAULIC SYSTEM, AND HOOK LIFT;
