AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID NO. QPA-5-2015 TO DELUXE INTERNATIONAL TRUCKS, INC., 600 SOUTH RIVER STREET, HACKENSACK, NJ 07601 – IN AN MOUNT NOT TO EXCEED \$154,900

WHEREAS, the Township of Morris has, in accordance with the Local Public Contracts Law of the State of New Jersey, received bids for the following:

PROCUREMENT OF ONE (1) 2016 INTERNATIONAL MODEL 7400 4X2 TWO WHEEL DRIVE OR EQUIVALENT CAB AND CHASSIS, SNOWPLOW, CENTRAL HYDRAULIC SYSTEM, AND HOOK LIFT;

That the subject contract be awarded pursuant to a fair and open process to Deluxe International Trucks, 600 South River Street, Hackensack, NJ 07601 in the amount of \$154,900 for a 2016 year model International Model 7400 4x2 Two Wheel Drive with cab and chassis, snowplow, central hydraulic system, and hook lift.
