AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID OTE: 2015-8 BLACKWELL AVENUE ROAD IMPROVEMENTS PROJECT TO MIDWEST CONSTRUCTION, INC., 23 DEAD RIVER ROAD, WARREN, NJ – IN AN AMOUNT NOT TO EXCEED \$313,769.42
