RESOLUTION NO. 204-17

AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID NO. QPA-6-2017 DELUXE INTERNATIONAL, 600 S. RIVER ST., HACKENSACK, NJ 07601 – IN AN AMOUNT NOT TO EXCEED \$157,900

WHEREAS, the Township of Morris has, in accordance with the Local Public Contracts Law of the State of New Jersey, received bids for the following:

PROCUREMENT OF ONE (1) 2018 INTERNATIONAL MODEL 7400 4X2 TWO WHEEL DRIVE OR EQUIVALENT, CAB & CHASSIS, SNOWPLOW, CENTRAL HYDRAULIC SYSTEM, AND HOOK LIFT; and

WHEREAS, after review and recommendation from the Qualified Purchasing Agent, it appears that the contract should be awarded to the lowest responsive and responsible bidder:



NOW, THEREFORE, BE IT HEREBY RESOLVED by the Township Committee of the Township of Morris, being the Governing Body of said Township, as follows:

1. That the subject contract be awarded pursuant to a fair and open process to Deluxe International, 600 S. River St., Hackensack, NJ 07601 in the amount of \$157,900 for a 2018 International Model 7400 4x2 Two Wheel Drive, Cab & Chassis, Snowplow, Central Hydraulic System, and Hook Lift.
2. The Mayor and Township Clerk are hereby authorized to execute the contract and all other necessary documents in order to effectuate the purpose of this resolution.
3. That the Certificate of Availability of Funds supplied by the Chief Financial Officer of this Township shall be attached to a copy of this resolution and kept on file in the Office of the Municipal Clerk.
