## RESOLUTION NO. 208-17

AUTHORIZING AWARD OF CONTRACT THROUGH A FAIR AND OPEN PROCESS FOR BID NO. QPA-5-2017 TO REHRIG PACIFIC COMPANY – IN AN AMOUNT NOT TO EXCEED UNIT PRICES OF \$42.12 PER 35 GALLON CONTAINER, \$49.68 PER 65 GALLON CONTAINER, AND \$54.47 PER 95 GALLON CONTAINER; TOTAL NOT TO EXCEED \$217,302

WHEREAS, the Township of Morris has, in accordance with the Local Public Contracts Law of the State of New Jersey, received bids for the following:

PROCUREMENT OF 35, 65, AND 95 GALLON RECYCLING CONTAINERS; and

WHEREAS, after review and recommendation from the Qualified Purchasing Agent, it appears that the contract should be awarded to the lowest responsive and responsible bidder:

WHEREAS, a Certificate of Availability of Funds has been provided to the Township Clerk by the Chief Financial Officer, certifying that the funds for said contract are available in the General Capital, Line No. G-04-55-607-501 in the amount of \$175,000 and G-04-55-705-501 in the amount of \$42,302.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Township Committee of the Township of Morris, being the Governing Body of said Township, as follows:

1. That the subject contract be awarded pursuant to a fair and open process to Rehrig Pacific Company, 1738 West 20<sup>th</sup> Street, Erie, PA 16502 for a total not to exceed \$42.12 per 35 Gallon Container, \$49.68 per 65 Gallon Container, and \$54.47 per 95 Gallon Container, for a grand total not to exceed \$217,302.
2. The Mayor and Township Clerk are hereby authorized to execute the contract and all other necessary documents in order to effectuate the purpose of this resolution.
3. That the Certificate of Availability of Funds supplied by the Chief Financial Officer of this Township shall be attached to a copy of this resolution and kept on file in the Office of the Municipal Clerk.
