AWARD OF A FAIR AND OPEN CONTRACT FOR DEBORAH DRIVE FENCING PROJECT TO ALL FENCE COMPANY, LLC, 26 EMMETT AVENUE, MORRIS TOWNSHIP, NEW JERSEY 07960 IN AN AMOUNT NTE \$26,965.80

WHEREAS, quotations were solicited through a fair and open process for the Deborah Drive Fencing Project, and

WHEREAS, quotations were mailed to six (6) vendors, and

WHEREAS, the Request for Quotation was advertised on the Township of Morris website in accordance with the Local Public Contracts Law, and

WHEREAS, four (4) quotations were received, opened, and read at a public bid meeting on April 10, 2013, and

WHEREAS, Karen J. Carman, Qualified Purchasing Agent has provided to the Governing Body a summary of quotations received along with a recommendation to award from the Township Engineer, and

WHEREAS, funds have been provided in Developer's Escrow and the Chief Financial Officer has certified to the availability of funds indicating that funds are available in Wheatsheaf Account No. 50125 in the amount of \$26,965.80, and

WHEREAS, after review and recommendation from the Township Engineer and Qualified Purchasing Agent, it appears that the contract should be awarded to the lowest responsive and responsible bidder:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Morris, being the Governing Body of said Township as follows:
