Family membership, resident or non-resident:

this membership includes a couple or widow or widower only and all children, natural or adopted, unmarried and living at home, including state ward children who are not yet twenty-three (23) years of age on July 1 of the membership year.

Couple membership, resident or non-resident:

this membership includes two people one of whom is an adult, who resides in the same dwelling. Child, if any who is not yet twenty-three (23) years of age on July 1 of the membership year.

Individual membership, resident or non-resident,

is available to any one individual 12 years of age or over. Children between the ages of 12 and 16 must successfully complete a swim pool proficiency test prior to obtaining an individual membership.

Senior citizen individual membership, resident or non-

resident, is available to any one individual who is of the age of 62 years or older on July 1 of the membership year, and such person must present proof of age at the time of application by either a photo static copy of his or her birth certificate or other proof satisfactory to the Township of Morris.

Senior citizen couple membership, resident or non-resi-

dent, is available to any senior couples who are of the age of 62 years or older on July 1 of the membership year, and such persons must present proof of age at the time of application by either a photo static copy of his or her birth certificate or other proof satisfactory to the Township of Morris.

Baby-sitter or parent's helper, resident or non-resident,

who does or does not reside in the same household, but must be accompanied by the children for which they are responsible and which children must be part of a household membership.
